Rector's Ordinance on Extraordinary Measures concerning Studies in the Summer Semester 2019/2020

Article 1

Alteration of the Rector's Ordinance No. R 395 on Organisation of the Academic Year 2019/2020

- 1. Point 17 of the Rector's Ordinance No. R395 on Organisation of the Academic Year from February 12, 2019, is altered thus: I determine the date 30.9.2020 as the final date for the assessment of studies (i.e., awarding course credits, organising colloquia or exams) in the academic year 2019/2020, as per Article 14 (2) of the Study and Examination Regulations of the University of South Bohemia (hereinafter as the "Study and Examination Regulations").
- 2. The alteration outlined in section 1 does not affect final dates for the assessment of studies previously determined by norms of Faculties.
- 3. The alteration outlined in section 1 does not affect the right of Deans to determine final dates for the assessment of studies via internal norms of Faculties.
- 4. Faculty deans have the right to update academic calendars of the year 2019/2020 published according to the Rector's Ordinance No. 395 in accordance with the needs of ongoing academic programs with regard to emergency measures concerning studies in the summer semester of 2019/2020.

Article 2

Implementing selected provisions of Study and Examination Regulations

- For the purposes of assessing requests of students concerning study matters, reasons worthy of
 considerations or serious medical reasons are such reasons that stem directly from the
 extraordinary situation caused by the coronavirus epidemics, including reasons related to work or
 professional duties, voluntary activities, care of a person of kin and the like. These reasons are
 considered relevant and valid when assessing requests of students submitted within the summer
 semester of 2019/2020, even without supporting evidence.
- 2. Requests submitted in the course of the summer semester of 2019/2020 and supported according to section 1 are processed free of charge; charges for discretionary administrative acts are not determined in these cases.
- 3. The provision shall not be applied to cases when the cancellation of course enrolment in the course of the summer semester of 2019/2010 results in not fulfilling the condition of the minimum amount of credits as per Article 20 (5) of the Study and Examination Regulations.
- 4. In the case of additional alterations to the schedule according to the timetable according to the Article 23 of the Study and Examination Regulations, provisions of the first and second sentence of the Article 23 (3) shall not be applied. Students may request a cancellation of a course



- enrolment due to the alteration of the timetable; this request shall be considered as a request in accordance with section 1.
- 5. The provision of Article 6 (7) of the Study and Examination Regulations shall not be applied to studies progressing in the summer semester of 2019/2020. Credits, earned by students in this semester, shall be added to the total number of credits gained, but their number shall not be monitored for the purposes of assessment of studies in the sense of assessment of the number of credits gained in this semester. In this sense, this semester shall also not be considered a part of the first two semesters of studies in the sense of the Article 31 (1), Subsection b) of the Study and Examination Regulations, or as a part of four consecutive semesters in the sense of the Article 31 (1), Subsection c) of the Study and Examination Regulations.
